◆◆◆ FLORIDA FAMILY ASSOCIATION SETTING MORAL STANDARDS FOR 17 YEARS ◆◆◆

RELENTLESS EFFORTS BY DAVID CATON RAISES THE BAR FOR MORALITY IN FLORIDA

With a heart full of faith and determination, David Caton embarked on a new mission and a new ministry and formed the Florida Family Association (FFA) in Tampa in 1987. Many of us in the Sunshine State who cherish righteousness and family values have reaped the benefits of the seeds that Caton has so relentlessly sowed.

**Getting Started and Updated**

Various supporters donated their time and money to equip FFA with several computers, copier, faxes and telephone system to get the organization up and running.

In an 'e-mail interview', Caton related, "We have designed software called Show Stopper that sends a personalized series of five fax letters to companies that advertise on certain television shows. The program tracks what shows each company advertises on.

"We also designed software called PornCrawler. It searched the World Wide Web, identified 297 porn links, researched which companies owned the sites and summarized the data for us. The names of both programs were given them by their separate computer programmers."

**Impacting businesses, television sponsors, city and county public officials**

FFA has written approximately 75,000 letters to companies regarding advertisements on irresponsible television shows and the sale of porn.

He has involved up to 35 people at one time recording programs for FFA across the state.

Caton has personally addressed over sixty city and county commissions, taking a stand against "legislating" immorality that would

adversely affect family and community.

**ACCOMPLISHMENTS**

**Stopped 'Special Rights' for homosexuals** from passing in the 1991 through 1994 Florida Legislative Sessions. FFA vigorously opposed the "sexual orientation" amendment that Gov. Chiles pushed for four straight years before conservatives won the majority of the House in 1994.

**Influenced nine major oil companies to prohibit the sale of pornographic magazines** by independent retailers who sell their brand of gasoline. The restrictions apply to over 75,000 stores.

**Influenced forty-six counties and cities** to enact laws to restrict sexually oriented business or prohibit nude clubs.

**Influenced over 2,500 companies to stop advertising on pornographic radio and television shows**, resulting in several shows being removed from the air on television networks and five radio stations in Florida.

Influenced over 20,000 stores to stop selling pornographic magazines.



**FFA August 2005 Update**  
**Currently...**FFA's review and study of the **Sexual Predator** issue continues to reveal a very troubling situation. We recently asked the Governor's Office to explain why there was an increase of 520 absconded sex offenders on the Florida Department of Law Enforcement (FDLE) web site. Rather than put their response in writing, the Governor's office called to tell us that we should be asking these questions to the FDLE. Unfortunately, the FDLE is not answering our questions. That is why we asked the Governor's Office.

FFA's most recent review found that there are 2,241 absconded sex offenders on the FDLE database. Finding these absconded sex offenders appears to be an overwhelming task for law enforcement.
